**Resolution # \_\_\_\_\_ -2022 Move to Adopt Local Law # \_\_ of 2022 “A local law to authorize the public bodies of the Town to use video conferencing technology to participate in public meetings”**

**WHEREAS**, upon proper notice a Public Hearing was held on the 14<sup>th</sup> day of September 2022, where all persons wishing to speak regarding proposed Local Law # \_\_ of 2022 were heard by the Enfield Town Board, and

**WHEREAS**, after consideration of all information presented and available, it is the determination of the Enfield Town Board that the Town will be best served adopt Local Law # \_\_ of 2022- “A local law to authorize the public bodies of the Town to use video conferencing technology to participate in public meetings”, so now therefore it be
